Explanatory notes

1. This application may affect allocation ownership

The holders of the allocation account that the water shares and the water-use licence/ registrations are to be linked to are the owners of any allocation in that account. This includes any allocation that is traded into that allocation account through this application, and future allocation derived from water shares that are linked to that allocation account.

2. Minimising the overall application fee to be charged

The application fee is equivalent to the current allocation trade fee for each water share and for each water-use licence/ registration added to the allocation account. In addition, each allocation trade also attracts an additional allocation trade fee.

Therefore, the allocation account you choose for your water shares and water-use licences/ registrations to be linked to can impact the overall application fee. You may wish to confirm with your water corporation how the overall fee can be minimised.

3. Water shares that may be included

All the water shares must be compatible with the nominated allocation account. This means that the water shares' trading zones must match the trading zones of the nominated allocation account. You should contact your water corporation if you are unsure on this.

4. Who must sign this application form

The application must be signed by all owners of each water share and by one of the holders of each water-use licence/ registration. This is necessary because:

- The water share owners are giving the future allocation from their water shares to the holders of the allocation account they are to be linked to.
- One of the holders of each water-use licence/ registration must consent to the use of that water on their land. Each person only needs to sign once, even if they own more than one water share and/ or are a holder of more than one water-use licences/ registration.

If a water share owner or a water-use licence/ registration holder is a company an authorised person must sign on behalf of the company. An ASIC company extract not more than 12 months old must also be attached. A company extract is available from www.asic.gov.au.

5. Holders and authorised agents of the allocation account

This application does not change the holders or authorised agents on any allocation account. Hence, any existing authorised agent can continue to trade allocation out of the allocation account.

6. Rescinding any link created by this application

To rescind this approval for a given water share or water-use licence/ registration, the respective owners must apply to link the water share or water-use licence/ registration to another allocation account. This is done via an application to transfer or vary the water share (a Form 1 or Form 9 application), or via an application to vary the water-use licence/ registration (a Form 24 application).

7. What is happening under the *Water Act 1989*

This form is an application, where applicable, for the Minister's approval to –

- give a water allocation assignment (under section 33X);
- take water outside the associated water system (under section 33AI);
- use water on land with which the water share is not associated (under section 64K);
- give a standing direction (under section 33TA); and/ or
- revoke a standing direction (under section 33TB).
