**Submission**

The application must be submitted to the account holder's water corporation by mail, fax or emailing a scanned copy of the hand-signed original application.

If submitted by email:

- The scanned copy of the hand-signed original application must be a separate file in 'portable document format' with the correct file extension (.pdf), and be attached to the email.
- The file must contain the application form and all supporting information (for example, authorised agent forms or company extracts).
- The file name must include the application number (in the form of REL123456), and may also include additional information.

Allocation may only be relinquished between:

- April 1st or the date that a low risk of spill declaration is made, whichever is later, and;
- June 30th (Applications should be submitted two weeks prior to June 30 otherwise processing cannot be guaranteed)
