**General – water-use licences or water-use registrations**

1. This application can be used to:
  - vary the allocation account (ABA) to which a water-use licence (WUL) or water-use registration (WUR) is linked
  - vary a works licence(s) (WLE) to which a WUL/WUR is linked
  - vary the annual use limit (AUL) of a WUL/WUR
  - vary WUL conditions, or WUR purpose
  - vary extraction share (notional rationing rate) on the general place of take approval related to AUL changes on the WUL/WUR.
2. It may be useful when completing this application to have the WUL or WUR Copy of Record. A Copy or Record is issued when a WUL or WUR is approved. Alternatively, you may obtain a Copy of Record from the water register website <https://www.waterregister.vic.gov.au/> or your Water Corporation.
3. WULs/WURs cannot be varied to add or remove a parcel of land (Volume/Folios). To add or remove Volume/Folios you must apply to cancel the WUL/WUR (using Form 25) and apply for a new WUL/WUR (using Form 23). Alternatively contact the Water Corporation to request an *Application to Restructure Water Services (Form 50)*.
4. You may nominate an existing ABA to link to the WUL/WUR, however if the holders of that ABA are different to the land owners, they will also need to sign the application form to apply for place of take approvals.
5. If you wish to link the water share/s that are associated to the nominated ABA directly to the WUL/WUR, please complete an application to Vary a Water Share (Form 9) and provide the application number in question 2.
6. You may nominate an existing ABA to remove from the WUL/WUR.

**Water-use licences only**

7. If you are applying to vary the area to be irrigated under a WUL or to vary the annual use limit (AUL), a revised Irrigation and Drainage Plan must accompany your application if required by the Water Corporation. Irrigation and Drainage Plan details are available at <http://www.land.vic.gov.au>
8. Your application will be referred to an Irrigation Development Case Manager if required by the Water Corporation.
9. If you want to add / vary or revoke any particular condition(s), other than the annual use limit, please notify your Water Corporation.
10. Lower Murray Water Customers please note: Your water-use licence may be in a salinity impact zone where there is a cap on annual use limits – please contact Lower Murray Water for advice.

**Water-use registrations only**

11. Water used under a WUR is not fit for any use that may involve human consumption without first being properly treated.
12. If you are seeking a change to the annual use limit or purpose for a water-use registration, you must specify the purpose at question 10.

**Place of take approvals**

**Note: Notional rationing rate under Section 3(1) of the Water Act 1989 is referred to as 'extraction share' in this form.**

13. As part of this application, the ABA holder(s) in question 2 are also applying for an approval to take their water at each service point (pump or outlet) linked to the water-use licence or registration (if they do not already hold such an approval). This *general place of take approval* (GPT) authorises the ABA holder(s) to take water from the identified approved place (at the service point), subject to any terms and conditions on the GPT.
14. If you are a river diverter, your GPT will also include your extraction share (ML/Day):
  - The extraction share is the basis on which restrictions will be imposed when river restrictions are required, meaning that if restrictions are in effect for a river reach, the proportion of a holder's extraction share they are authorised to take during that period will be announced.
  - During periods of normal river flow, the extraction share does not constrain the holder's right to take water.
  - It's an offence to fail to comply with an announced river restriction.
  - In uncapped areas, you may apply for extraction share to be issued on your GPT via a Form 14 (Vary Extraction Share), or alternatively, if you are applying to change your annual use limit (AUL) under question 6 or 9 you may use this form to apply to vary extraction share in line with your annual use limit and subject to Ministerial Rules.
  - In capped areas, no new extraction share will be issued. This means that to obtain extraction share you will need to source and apply for a transfer of extraction share (Form 16), subject to assessment in line with Ministerial Rules.
15. If you are a district user, your GPT will not include an extraction share as your delivery share is used to manage restrictions if needed.
16. Holders of a GPT may also be subject to prohibitions in prescribed circumstances. For example, the taking of water from one trading zone that is 'tagged' for use in another trading zone is prohibited when allocation trade between those zones is prohibited.
17. As part of this application, in question 3 the water-use licence or registration holder can also revoke their consent for the ABA holder(s) to use their water on the land, which will result in the ABA holder's GPT being cancelled. If the ABA holder's GPT has a non-zero extraction share, the Water Corporation will notify the ABA holder before the GPT is cancelled.

**Lodgement**

19. This application must be submitted complete with payment, to the Water Corporation by mail, in person or emailing a scan of the original hand-signed application.

21. All land owner(s) must sign. Applications made by prescribed persons (refer to s.64APAA of the Act) may be exempt, and in this case the prescribed person(s) must sign. Please contact the Water Corporation in the first instance.
22. If any ABA holders in question 2 are different to the land owners, they must also sign the application.
23. If there is insufficient space for all land owner(s) or ABA holders to sign this form, please ensure the relevant Form 24 Annexure is completed.
24. Signatories for a company (e.g. Director or Company Secretary) must sign in accordance with an ASIC company extract not more than 12 months old. Only persons listed on the ASIC company extract can sign. A copy of the ASIC company extract must be attached to the application.

**Approval of the application**

25. If the application is approved, a letter will be sent to the land owner/prescribed person. A WUL or WUR Copy of Record will be attached.
26. If you are a river diverter, the ABA holder(s) in question 2 will also be sent a letter stating they have been issued a general place of take approval (GPT) and particular place of take approvals, as applicable. A GPT Copy of Record will be attached and will state any terms and conditions that apply including extraction share.
27. If you are a river diverter and the ABA holder(s) in question 3 hold a GPT with extraction share greater than zero, they may also be sent a letter stating the Water Corporation's intent to cancel their GPT due to the WUL/R holder withdrawing their consent to use water on the land.
28. A letter will also be sent to the lodging party if a lodging party coordinated the application.

### More information required

29. If the Water Corporation requires more information the applicant and the lodging party will be notified if applicable stating the missing and/or incorrect information that requires correction.
30. Applicants must provide missing information or correct information within two calendar months, or the application will lapse and a new application would need to be lodged with another application fee.

### Refusal of the application

31. If the Water Corporation refuses the application, the Water Corporation will send a letter stating the reasons for the refusal to the applicant(s). A letter will also be forwarded to the lodging party, if applicable.

### What is happening under the *Water Act 1989*

32. This form is an application, where applicable, for the Minister's approval to:

- Vary a water-use licence that authorises the use of water on land for the purposes of irrigation (under section 64AH);
- Vary a water-use registration that authorises the use of water on land for purposes other than irrigation (under section 64AU);
- Obtain a general place of take approval which approves the place at which water can be taken, subject to any terms and conditions (under section 64FC);
- Obtain a particular place of take approval which approves a person to take water at the approved place (under section 64FZJ);
- Vary the notional rationing rate on application by the approval holder (under section 64FY); and
- Cancel a general place of take approval held by the water-use licence or registration holder (under section 64FR).

This form may also be a notification by the water-use licence or registration holder to the Minister that you have removed your consent for an ABA holder to use water on the land specified in your water-use licence or registration, and this information can be used by the Minister to cancel the revoked ABA holder's general place of take approval (under section 64FS(2)). The revoked ABA holders that hold extraction share will be notified before their general place of take approval is cancelled. **Note: A reference in these notes to actions to be undertaken by the Water Corporation may mean the Water Corporation is acting as delegate of the Minister under section 306.**
