## Explanatory notes

### Submission

This application can be submitted to the seller's water corporation over the counter, by fax, or by emailing a scanned copy of the original hand signed application.

For the application to be approved the seller and buyer must ensure:

- All the holders of the seller's allocation account sign the application; OR
- A person authorised to sign on behalf of the holders of the sellers' allocation account signs the application. See the section below titled 'How to authorise a person to sign';
- The correct allocation account identification number has been provided;
- The application complies with the water trading rules;
- The seller has sufficient allocation for this trade;
- The application is complete and legible; and
- The application fee is paid when the application is submitted.
- The water corporation may refuse incomplete applications and the application fee may be retained.

### Emailing your application

If you are lodging this application by email you will need to contact the water corporation to pay the application fee. The water corporation cannot process your application until the application fee has been paid. The water corporation's email address and contact number are included below.

### How to authorise a person to sign

If you want to give a person(s) ongoing approval to trade from your account including online access complete Form 39a and lodge with your water corporation. Form 39a can be downloaded from <https://waterregister.vic.gov.au/about/forms-and-fees/allocation-forms>.

If you want to give a person(s) approval to trade from your account for a limited period complete Form 39b and attach it to this application. Form 39b can be downloaded from <https://waterregister.vic.gov.au/about/forms-and-fees/allocation-forms>.

### If the seller is a company or incorporated association

Companies must attach an ASIC company extract that is less than 12 months old. Two directors or one director and secretary are required to sign. Incorporated associations must attach an incorporated association extract that is less than 12 months old. The listed secretary is required to sign.

### Interstate trade

This form does not require an ABA number, a name or a signature for an interstate party. Simply tick the state (at question 3 or 6) and attach a copy of the interstate application form.

### All remaining tradeable allocation

In this form all remaining tradeable allocation means the tradeable volume of allocation in the seller's ABA to one decimal place, rounded down, at the time this application is approved by the water corporation.

The option to trade all remaining tradeable allocation is not available for interstate trades.

For GMW and LMW trades, any spillable account balance will not be included. A separate application may be required when the spillable allocation is returned to the tradeable balance.

### What is happening under the Water Act 1989

This form is an application, where applicable, for the Minister's approval to:

- Give a water allocation assignment (under sections 33V, 33X, 46, 46A, 48L and 48M);
- Take interstate water (under section 33AG);
- Obtain an external place of take approval (under section 64FZT); and
- Obtain a particular place of take approval which approves a person to take water at the approved place (under section 64FZJ).
