Explanatory notes

This application is used to surrender a water share. Surrendering a water share will cause it to be cancelled.

This application is also used to facilitate an entitlement transfer by cancelling one water share and issuing another water share with a different water system, or to issue a take and use licence for an unregulated system.

These are known as exchange rate trades. Exchange rate trades are subject to trading rules. The trading rules can be found here: <http://waterregister.vic.gov.au/water-trading/trading-rules>. Contact your water corporation for more information.

If you are surrendering your water share for an exchange rate trade to issue a new water share, then this application needs to be accompanied by a separate application for the issue of a new water share (Form 7).

Encumbrances on the water share and monies owing

A water share that has a recorded mortgage or limited term transfer cannot be cancelled. In these instances the mortgage and limited term transfer must first be discharged.

The water corporation may not cancel the water share until all storage fees owing on the water share are paid.

Identity check

The water corporation will not process the application unless each owner of the water share has provided the water corporation with a 100-point identification check. The identity check form can be found here: <https://waterregister.vic.gov.au/about/forms-and-fees/water-share-forms>.

Lodging the application

All owners of the water share being surrendered must sign this application and complete a 100-point identification check.

Companies must attach an ASIC company extract that is less than 12 months old. Two directors or one director and secretary are required to sign.

Incorporated associations must attach an incorporated association extract that is less than 12 months old. The listed secretary is required to sign.

The water corporation will notify the owners and the lodging party by letter when the water share has been cancelled.

What is happening under the Water Act 1989

This form is an application, where applicable, for the Minister's approval:

- To surrender the water share to the Crown (under section 33AA); and
- For the water share to be cancelled on the issuing of a take and use licence (under section 33ABA).
